## Registration of Ownership

When you purchase your motorcycle, you and the selling dealer will complete the Warranty Registration Card and send it to Excelsior-Henderson. We will then send your Owner/Warranty Identification Card to you in the mail.

Keep the Owner/Warranty Identification card with you - it validates your warranty and identifies you to your Excelsior-Henderson dealer. Present this card to your Excelsior-Henderson Dealer at the time warranty work is needed.

Planning to sell your motorcycle? We have included a *Warranty Transfer Card* in this booklet for your buyer's use should you sell your motorcycle within the warranty period.

Planning to move? We would like to keep you informed about safety and service developments concerning your motorcycle. Use the *Address Update Card* in this booklet to inform us of your new address.

# **Excelsior-Henderson Motorcycle Manufacturing Co. Limited Warranty**

## **12 Months Unlimited Mileage**

Excelsior-Henderson warrants to the first retail purchaser of each new 2000 model motorcycle purchased from any authorized Excelsior-Henderson Dealer, that such motorcycle will be free from defects in materials and workmanship for the twelve-month period described in the following pages. Excelsior-Henderson will repair or replace (at its option) without charge any parts (except tires, maintenance items and battery under certain conditions) found to be defective in materials or workmanship under normal use in the U.S.A. or Canada, upon the following terms and conditions:

## **Owner Obligations**

To obtain warranty protection:

You and the selling Dealer must complete the Warranty Registration Form and return it to us within 10 days after delivery so we may send you an Owner/Warranty Identification Card.

To obtain warranty service:

1. You must give notice to an authorized Excelsior-Henderson Dealer of any and all apparent defects as promptly as practicable after discovery;
2. Present your Owner/Warranty Identification Card to an authorized Excelsior-Henderson Dealer; and
3. Deliver your motorcycle at your expense to an authorized Excelsior-Henderson Dealer.

Our Dealer will provide warranty service only during normal business hours and as soon as practicable considering the workload of the Dealer's service department and the availability of necessary parts.

## **Duration And Transfer**

This warranty is limited to a period of twelve months after the date of initial retail purchase from an authorized Excelsior-Henderson Dealer.

Any unexpired portion of this limited warranty may be transferred, with written authorization from Excelsior-Henderson, upon the resale of the motorcycle during the warranty period. To obtain authorization, a transfer application must be filed with Excelsior-Henderson and the motorcycle must pass inspection by one of our authorized Dealers.

## **Exclusions**

### **Important-Read Carefully**

1. Excelsior-Henderson will not be obligated to replace or repair any motorcycle:
  - which has not been operated or maintained as specified in the Rider's Handbook; or
  - which has been abused, altered outside of original factory specifications, improperly stored or used "off the highway," or for racing or competition of any kind.
2. Our Dealers are independently owned and operated and sell other products. Because of this, Excelsior-Henderson is not responsible for the safety, quality or suitability of any non-Excelsior-Henderson part, accessory or design modification including labor which may be sold and/or installed by our dealers.
3. THERE IS NO OTHER EXPRESSED WARRANTY (OTHER THAN EMISSIONS AND NOISE WARRANTIES) ON THE MOTORCYCLE. ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS IS LIMITED TO THE TWELVE-MONTH PERIOD OF THIS WARRANTY.
4. TO THE FULLEST EXTENT ALLOWED BY LAW, EXCELSIOR-HENDERSON AND ITS DEALERS SHALL NOT BE LIABLE FOR LOSS OF USE,

**INCONVENIENCE, LOST TIME, COMMERCIAL LOSS OR OTHER  
INCIDENTAL OR CONSEQUENTIAL DAMAGES.**

Some states do not allow the exclusion or limitation of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above limitations and exclusions may not apply to you. This warranty gives you specific legal rights, and you may have other rights which vary from state to state.

## **Other Limitations**

This warranty does not cover:

1. Parts and labor for normal maintenance as recommended in the Rider's Handbook, including such items as the following: lubrication, oil and filter change, fuel system cleaning, battery maintenance, engine tune-up, spark plugs, light bulbs, brake, clutch and drive belt adjustment (including drive belt replacement).
2. Seats, saddlebags, paint, chrome or trim deterioration caused by ordinary wear and tear, exposure or improper maintenance.
3. Parts used in warranty repairs will be warranted for the balance of the motorcycle's warranty period.

## Accessories Limited Warranty

Excelsior-Henderson warrants Excelsior-Henderson™ brand accessories that are installed by an authorized Excelsior-Henderson Dealer prior to delivery of a new 2000 model motorcycle to be free from defects in materials, workmanship, and construction. Should the product fail due to a defect in material, workmanship, and/or construction, after normal use, Excelsior-Henderson Motorcycle Manufacturing Company will repair or replace the product, at its option, at no charge for a period of twelve (12) months after the date of the initial retail purchase of the motorcycle on which the accessory was installed. The defective product must be inspected and repaired or replaced by an authorized Excelsior-Henderson Dealer. Changes, modifications, or alterations to the accessories will not be covered by this warranty. Product repaired or replaced under this warranty will assume the balance of the original twelve (12) month warranty period.

If the product includes leather, given the characteristics of full-grain leather, no warranty is extended for color variations, naturally occurring marks, or other imperfections indigenous to the product.

EXCELSIOR-HENDERSON MOTORCYCLE MANUFACTURING COMPANY MAKES NO OTHER WARRANTIES OR REPRESENTATIONS OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Accessories purchased at any other time (other than at the time of purchase of a new 2000 model motorcycle) are covered by a separate warranty included with the accessories.

# Noise Control System Warranty

The following warranty applies to the noise control system, including the exhaust system, and is in addition to the Limited Warranty and Emission Control System Warranty.

Excelsior-Henderson warrants to the first purchaser and each subsequent purchaser that this vehicle is designed and built so as to conform at the time of sale with noise regulations of the U.S. Environmental Protection Agency applicable at the time of manufacture and that it is free from defects in materials and workmanship which would cause this motorcycle not to meet U.S. Environmental Protection Agency noise regulations within 1 year or 3,730 miles (6,000 kilometers), whichever occurs first.

The warranty period shall begin on the date the motorcycle is delivered to the first retail purchaser or, if the motorcycle is placed in service as a demonstrator or company vehicle prior to sale at retail, on the date it is first placed in service.

## Exclusions

The following items are not covered by the Noise Control System Warranty:

1. Failures which arise as a result of misuse, alterations or accident as specified in the Rider's Handbook.

2. Replacing, removing or modifying any portion of the Noise Control System (consisting of the exhaust system and air intake/cleaner assembly) with parts not certified to be noise legal for street use.
3. Loss of time, inconvenience, loss of motorcycle use, commercial losses or other incidental or consequential damages.
4. Any motorcycle on which the odometer mileage has been changed so that the mileage cannot be determined.

## **Recommendations for Required Maintenance**

IT IS RECOMMENDED THAT ANY NOISE SYSTEM MAINTENANCE BE PERFORMED BY AN AUTHORIZED EXCELSIOR-HENDERSON DEALER USING GENUINE EXCELSIOR-HENDERSON REPLACEMENT PARTS. THE MAINTENANCE, REPLACEMENT OR REPAIR OF THE NOISE CONTROL SYSTEM MAY BE PERFORMED BY ANY OTHER QUALIFIED SERVICE OUTLET OR INDIVIDUAL. NON-GENUINE PARTS MAY BE USED ONLY IF SUCH PARTS ARE CERTIFIED TO COMPLY WITH U.S. ENVIRONMENTAL PROTECTION AGENCY REGULATIONS.

# Noise Control Regulations

## Tampering With The Noise Control System Prohibited

Owners are warned that federal law prohibits:

1. The removal or rendering inoperative by any person other than for purposes of maintenance, repair or replacement, of any device or element of design incorporated into any new vehicle for the purpose of noise control prior to its sale or delivery to the ultimate purchaser or while it is in use; and
2. The use of the vehicle after such device or element of design has been removed or rendered inoperative by any person.

Acts which are likely to constitute tampering include the following:

1. Removal or tampering with the mufflers, baffles or header pipes or any other component which conducts exhaust gases.
2. Removal of or puncturing of any part of the air intake system.
3. Failure to carry out maintenance as prescribed in the Rider's Handbook.
4. Replacement of any parts of the exhaust or air intake system with parts other than those specified by Excelsior-Henderson.

**⚠ WARNING**

This product should be checked for repair or replacement if the motorcycle noise has increased significantly through use, otherwise the owner may become subject to penalties under state and local ordinances.

# **Emission Control System Warranty**

The following warranty applies to the emission control system and is in addition to the Limited Warranty and Noise Control System Warranty.

Excelsior-Henderson warrants to the first purchaser and each subsequent purchaser that this vehicle is designed, built and equipped so as to conform at the time of sale with emission regulations of the U.S. Environmental Protection Agency applicable at the time of manufacture and that it is free from defects in materials and workmanship which would cause this motorcycle not to meet applicable U.S. Environmental Protection Agency emission regulations within 5 years or 18,641 miles (30,000 kilometers), whichever occurs first.

The warranty period shall begin on the date the motorcycle is delivered to the first retail purchaser or, if the motorcycle is placed in service as a demonstrator or company vehicle prior to sale at retail, on the date it is first placed in service.

## **Exclusions**

The following items are not covered by the Emission Control System Warranty:

1. Failures which arise as a result of misuse, alterations, accident or non-performance of maintenance as specified in the Rider's Handbook.

2. The replacement of parts (such as spark plugs, fuel and oil filters, etc.) used in required maintenance.
3. Loss of time, inconvenience, loss of motorcycle use, commercial losses or other incidental or consequential damages.
4. Any motorcycle on which the odometer mileage has been changed so that the mileage cannot be determined.

## **Recommendations for Required Maintenance**

IT IS RECOMMENDED THAT ANY EMISSION SYSTEM MAINTENANCE BE PERFORMED BY AN AUTHORIZED EXCELSIOR-HENDERSON DEALER USING GENUINE EXCELSIOR-HENDERSON REPLACEMENT PARTS. THE MAINTENANCE, REPLACEMENT OR REPAIR OF THE EMISSION CONTROL SYSTEM MAY BE PERFORMED BY ANY OTHER QUALIFIED SERVICE OUTLET OR INDIVIDUAL. NON-GENUINE PARTS MAY BE USED ONLY IF SUCH PARTS ARE CERTIFIED TO COMPLY WITH U.S. ENVIRONMENTAL PROTECTION AGENCY REGULATIONS.

# **California Emission Control System Warranty Statement**

## **Your Warranty Rights And Obligations**

The California Air Resources Board and Excelsior-Henderson, are pleased to explain the emission control system warranty on your 2000 motorcycle. In California new motor vehicles must be designed, built and equipped to meet the State's stringent anti-smog standards. Excelsior-Henderson must warrant the emission control system on your motorcycle for the periods of time listed below provided there has been no abuse, neglect or improper maintenance of your motorcycle.

Your emission control system may include parts such as the fuel-injection system, the ignition system and engine computer. Also included may be hoses, belts, connectors and other emission-related assemblies.

Where a warrantable condition exists, Excelsior-Henderson will repair your motorcycle at no cost to you, including diagnosis, parts and labor.

## **Manufacturer's Warranty Coverage**

For a period of use of five (5) years or 18,641 miles (30,000 kilometers), whichever first occurs:

If any emission-related part on your motorcycle is defective, the part will be repaired or replaced by Excelsior-Henderson. This is your emission control system DEFECTS WARRANTY.

## **Owner's Warranty Responsibilities**

As the motorcycle owner, you are responsible for the performance of the required maintenance listed in your Rider's Handbook. Excelsior-Henderson recommends that you retain all receipts covering maintenance on your motorcycle, but Excelsior-Henderson cannot deny warranty solely for the lack of receipts or for your failure to ensure the performance of all scheduled maintenance.

You are responsible for presenting your motorcycle to an Excelsior-Henderson Dealer as soon as a problem exists. The warranty repairs should be completed in a reasonable amount of time, not to exceed 30 days.

As the motorcycle owner, you should be aware that Excelsior-Henderson may deny your warranty coverage if your motorcycle or a part has failed due to abuse, neglect, improper maintenance or unapproved modifications.

If you have any questions regarding your warranty rights and responsibilities, you should contact Excelsior-Henderson Motorcycle Manufacturing Co., 805 Hanlon Drive, Belle Plaine, MN 56011, or the California Air Resources Board at P.O. Box 8001, 9528 Telstar Avenue, El Monte, CA 91734-8001.

## **California Emission Control Warranty**

The following warranty applies to the Emission Control System and is in addition to the Limited Warranty, the Emission Control System Warranty and the Noise Control System Warranty. Excelsior-Henderson warrants to the first purchaser, and each subsequent purchaser, that each new 2000 Excelsior-Henderson motorcycle initially sold in the State of California:

- is designed, built and equipped so as to conform at the time of initial retail purchase with all applicable regulations of the California Air Resources Board; and
- is free from defects in material and workmanship which would cause such motorcycle to fail to conform with applicable regulations of the California Air Resources Board for a period of use of 18,641 miles (30,000 kilometers) or five (5) years from the date of initial retail delivery, whichever first occurs.

## **Coverage**

Warranty defects shall be remedied during customary business hours at any authorized Excelsior-Henderson Dealer in compliance with the applicable regulations of the California Air Resources Board. Any part or parts replaced under this warranty shall become the property of Excelsior-Henderson.

Emission related warranted parts are specifically defined by the State of California's Emission Warranty Parts List. These warranted parts are: intake manifold; fuel tank; fuel injection system; spark advance mechanism; crankcase breather; air cutoff valves; fuel tank cap for evaporative emission controlled vehicles; oil filler cap; pressure control valve; fuel/vapor separator; canister; ignition coils; ignition wires; and spark plugs (if failure occurs prior to the first scheduled replacement at 10,000 miles); and hoses, clamps, fittings and tubing used directly in these parts.

Although an Excelsior-Henderson authorized Dealer is recommended, Emission Control System "emergency" repairs, as provided for in the California Administrative Code, may be performed by other than an authorized Excelsior-Henderson Dealer. An "emergency" situation occurs when an authorized Excelsior-Henderson Dealer is not reasonably available, a part is not available within 30 days, or a repair is not complete within 30 days. Any replacement part can be used in an "emergency" repair. Excelsior-Henderson will reimburse the owner for the expenses, including diagnosis, if it is found that the repairs are covered under this warranty. Reimbursement will not exceed

Excelsior-Henderson's suggested retail price for all warranted parts replaced and labor charges based on Excelsior-Henderson's recommended time allowance for the warranty repair and the geographically appropriate hourly labor rate. The owner must keep receipts and failed parts and return them to an authorized Excelsior-Henderson Dealer in order to receive compensation. It is recommended that the "emergency" repairs be inspected by an authorized Excelsior-Henderson Dealer.

## Limitations

This Emission Control System warranty shall not cover any of the following:

- Repair or replacement required as a result of
  - accident, acts of nature
  - misuse,
  - repairs improperly performed or replacements improperly installed,
  - use of replacement parts or accessories not conforming to Excelsior-Henderson specifications which adversely affect performance and/or
  - use in competitive racing or related events.
- Inspections, replacement of parts and other services and adjustments required for required maintenance.

- Any motorcycle on which the odometer mileage has been changed so that actual mileage cannot be readily determined
- Loss of time, inconvenience, loss of use of the motorcycle or commercial loss.
- Repairs performed by other than an authorized Excelsior-Henderson Dealer except in case of an “emergency” as defined above.

## **Additional Information**

Any replacement part that is equivalent in performance and durability may be used in the performance of any maintenance or repairs and will not invalidate the warranty unless non-Excelsior-Henderson parts cause damage to warranted parts. However, Excelsior-Henderson is not liable under this warranty with respect to any parts which are not genuine Excelsior-Henderson parts. The owner is responsible for the performance of all required maintenance. Such maintenance may be performed at a service establishment or by any individual. The warranty period begins on the date the motorcycle is delivered to an ultimate purchaser.

# Service Records

The following pages provide a schedule of service to help you keep your motorcycle running in top form. It will also help you satisfy your warranty responsibilities. For each mileage interval there is a checklist of service items and room to record observations and modifications. There is also a place for you, your Excelsior-Henderson dealer, or another service provider to enter the date, the mileage, and a signature to affirm the work that was done. Refer to your Rider's Handbook and the Excelsior-Henderson Service Handbook for service information. We recommend that you save all repair documents.

The following service items have additional instructions to remember:

- **Engine oil and filter:** Change at the specified intervals or annually, whichever comes first.
- **Clutch and brake hydraulic fluid:** Replace the hydraulic fluid at the specified intervals or every three years, whichever comes first.
- **Wheel bearings:** Inspect wheel bearings during tire replacement.
